

Retreat Payment Plan, Refund and Cancellation Policy

Thank you for joining Life With Tania d/b/a Wanderlust Sisters for the **Building Sisterhood Retreat in Colombia**. The Retreat shall offer multiple accommodation offers: different shared room options or an individual private eco-hut. Neither option is to be considered greater than the other, nor shall either option be promoted more over another. Instead, the shared room or individual room option is presented as a means to offer another meaningful manner for Participants to enjoy the retreat experience.

The cost and payment plan after the \$400 deposit of the Retreat varies by room type and is as follows:

This flat fee includes the following: 7 nights of accommodation at the Finca Carpe Diem; all breakfast, lunch and dinners (except arrival day - dinner only, and departure day - breakfast only); general refreshments, beverages, cacao ceremony, sound bath, yoga sessions, drumming, swimming, and other activities, as well as transportation back and forth from the main Santa Marta airport. Additional information regarding this retreat can be found in the promotional material provided.

At the time of your reservation for the Retreat, the Participant must produce the non-refundable deposit of \$400 USD ("Deposit"). This Deposit counts toward the total cost of the Retreat, which stated above.

The payments shall be paid online at <https://tri.ps/aVx5i>. Participants can either pay in monthly installments or in total up front. For the monthly installments, each payment is set-up via third party payment plan WeTravel.

Life With Tania shall provide for partial refunds as long as the request is made at the earlier of 70 (seventy) days before the scheduled trip in May. The final date where a request can be made shall be Saturday, March 1, 2025. Any request for a refund will not be accepted at any point after March 2, 2025.

Upon a timely request, the partial refund shall be half of what has already been paid, but no more than half of what the Participant has already paid. The refund will be paid via PayPal. If a conflict arises, the reserved party will be able to transfer their reservation to another party. The new party will then have to submit the \$400.00 USD deposit. The transferring party will not be afforded a refund as they are not formally requesting a refund, rather they are simply making a reservation transfer and the new reserved party will take place of initial party at the Retreat. In the event there are still remaining payments to be made, the new party/Participant shall make those payments.

Lastly, if a party is required to cancel, the cancellation should be submitted by the Saturday, March 1, 2025. Anything beyond that time frame, the party will not receive any refund or return of monies spent toward the payment of the Retreat.

This policy shall be effective from January 1, 2023 and the Participant/reserved party shall be bound by this Policy upon reserving their place with the Retreat.
